# **Trusted Domain Project Intellectual Property Policy**

# Ratified by the Board of Directors on November 7, 2011

## I. INTRODUCTION

The Trusted Domain Project (hereinafter "TDP") is a public interest non-profit California corporation dedicated to the development and advancement of open standards and open software furthering the goal of restoring public trust in the use of domain names on the Internet.

In all matters of copyright and document procedures within TDP, the intent is to benefit the community and the public at large, while respecting the legitimate rights of others. This policy applies to all such matters.

## **II. DEFINITIONS**

A "Contribution" is any oral or written submission, comment, or discussion, made in the context of an activity of the TDP, including but not limited to mailing lists, conference calls, source code repositories, meetings, documents, and databases.

A "Contributor" is any individual submitting a Contribution.

"Copyright" is the legal right granted to an author in a document or other work of authorship under applicable law. An author often cedes these rights to their employer or other parties as a condition of employment or compensation.

The terms "Initiative" and "Manager" are defined in the TDP Initiative Policy.

## III. GENERAL

In order for Contributions to be used within the auspices of TDP or one of its Initiatives, including when they are published, certain limited rights must be granted to TDP. In addition, Contributors must be able to make representations to TDP regarding their ability to grant these rights.

By submission of a Contribution, each person actually submitting the Contribution and each named co-Contributor is deemed to have read and understood this policy. Each Contributor is deemed, by the act of submitting a Contribution, to enter into a legallybinding agreement to comply with the terms and conditions set forth in this policy.

The Contributor is further deemed to have agreed that he/she has obtained the necessary permissions to enter into such an agreement from any party that the Contributor reasonably and personally knows may have rights in the Contribution, including, but not limited to, the Contributor's sponsor or employer.

No further acknowledgement, signature, or other action is required to bind a Contributor to these terms and conditions. The operation of the TDP and the work conducted by its various participants is dependent on such agreement by each Contributor, and each participant expressly relies on the agreement of each Contributor to the terms and conditions set forth in this policy.

It is incumbent upon the Board, and the Managers of Initiatives, to notify and periodically remind participants in TDP activities that their Contributions are covered by this policy, which affects their rights regarding those Contributions.

## IV. CONFIDENTIALITY

No information or document that is subject to any requirement of confidentiality or any restriction on its dissemination may be submitted as a Contribution or otherwise considered in any TDP activity, and there must be no assumption of any confidentiality obligation with respect to any Contribution. Each Contributor agrees that any statement in a Contribution, whether generated automatically or otherwise, that states or implies that the Contribution is confidential or subject to any privilege, can be disregarded for all purposes, and will be of no force or effect.

# V. RIGHTS GRANTED

To the extent that a Contribution or any portion thereof is protected by copyright or other rights of authorship, the Contributor and each named co-Contributor grant a perpetual, irrevocable, non-exclusive, royalty-free, world-wide, sublicensable right and license to TDP under all such copyrights and other rights in the Contribution:

- 1. to copy, publish, display, and distribute the Contribution, in whole or in part,
- 2. to prepare translations of the Contribution into languages other than English, in whole or in part, and to copy, publish, display, and distribute such translations or portions thereof,
- 3. to modify or prepare derivative works (in addition to translations) that are based on or incorporate all or part of the Contribution, and to copy, publish, display, and distribute such derivative works, or portions thereof unless explicitly disallowed in the notices contained in a Contribution (in the form specified by the Legend Instructions), and
- 4. to reproduce any trademarks, service marks, or trade names that are included in the Contribution solely in connection with the reproduction, distribution, or publication of the Contribution and derivative works thereof as permitted by this Section, provided that when reproducing Contributions, trademark and service mark identifiers used in the Contribution, including <sup>TM</sup> and <sup>®</sup>, will be preserved.

VI. SUBLICENSE

TDP hereby grants a sublicense of these rights to the general public, provided the above copyright notice is retained in any copies and derivative works.

## VII. NO PATENT LICENSE

The licenses granted in Section V shall not be deemed to grant any right under any patent, patent application, or other similar intellectual property right disclosed by the Contributor.

## VIII. REPRESENTATIONS AND WARRANTIES

With respect to each Contribution, each Contributor represents that, to the best of their knowledge and ability:

- 1. The Contribution properly acknowledges all Contributors, including any Indirect Contributors.
- 2. No information in the Contribution is confidential, and TDP, and its affiliated organizations, may freely disclose any information in the Contribution.
- 3. There are no limits to the Contributor's ability to make the grants, acknowledgments, and agreements herein that are reasonably and personally known to the Contributor.
- 4. The Contributor has not intentionally included in the Contribution any material that is defamatory or untrue or which is illegal under the laws of the jurisdiction in which the Contributor has his or her principal place of business or residence.
- 5. All trademarks, trade names, service marks, and other proprietary names used in the Contribution that are reasonably and personally known to the Contributor are clearly designated as such where reasonable.

#### IX. NO DUTY TO PUBLISH

The Contributor, and each named co-Contributor, acknowledges that TDP has no duty to publish or otherwise use or disseminate any Contribution. TDP reserves the right to withdraw or cease using any Contribution that does not comply with the requirements of this policy.

#### X. TRADEMARKS

Contributors who claim trademark rights in terms used in their TDP Contributions are requested to state specifically what conditions apply to implementers of the technology relative to the use of such trademarks. Such statements should be made to the Board of Directors, or to the Manager of the relevant Initiative who will then forward that claim to the Board.

#### XI. COPYRIGHT IN OUTPUT

Subject to each Contributor's (or its sponsor's) ownership of its underlying Contributions as described above (which ownership is qualified by the irrevocable licenses granted under Section V), each Contributor hereby acknowledges that the copyright in any TDP publication in which such Contribution is included shall be owned by TDP. Such Contributor shall be deemed to assign to TDP such Contributor's copyright interest in the collective work constituting the output upon the submission of such output for publication, and acknowledges that a copyright notice acknowledging TDP ownership of the copyright in such output will be included in the published output.

Any document of any kind, including but not limited to documentation, educational materials, and source code, that contains a Contribution submitted under this policy shall indicate that TDP has the rights to use the Contributions contained therein by including this notation near the top or bottom of the document:

# XII. CONTRIBUTORS' RETENTION OF RIGHTS

Although Contributors provide specific rights to TDP, it is not intended that this should deprive them of their right to exploit their Contributions. To underscore this principle, TDP will upon request issue a license or assurance to Contributors, which confirms that they may each make use of their Contributions as published in any TDP output in any way they wish, subject only to the restriction that no Contributor has the right to represent any document as a product of TDP, or equivalent to same, if it is not a full and complete copy or translation of a published output of TDP.
